This house is very similar in scale and appearance to the house at 304 Fifth Avenue and shares many of the same carpenter Queen Anne features, especially the wealth of wood details. The house is covered with wood in a variety of forms, including fish scale, scalloped and square shingles as well as plain wood siding. There are several bay windows and multi-paned windows typical of the Queen Anne style. The principle gable has a projecting window along with brackets and pendants under the cornice.


