DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

This stone stucco house is L shaped. 2 stories high, 4 bays by 2 in the main section, 2 bays by 1 in the wing. Facing south, the pitched roof/ridge line runs east-west; the wing lies to the north along the west end wall.

On plan, a two-front-parlor house with two doors on the front of the house, center.

There are 3 chimneys rising inside the three end walls, all closed off except that the ~~wing~~ ^{wing} fire place is removed to make room for a stove.

Windows have 6 lights each and interior walls are curved at the window opening to admit extra light.
