DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The facade of this building is similar to two dwellings on Charles Street. It is a two bay, two story building with the entrance located on the eastern side of the facade with two windows west thereof. Two windows light the second story of the facade as well as the east gable. North of the main body of the structure is a small two story wing with concrete block leanto built onto its east side.

The walls of the building are covered with grey-green siding and the roof is covered with asphalt shingle. A stuccoed chimney rises within the west gable. A small casement lights the garrett in the east gable. All windows have 1/1 sash and white trim.

STATEMENT OF SIGNIFICANCE

Architecturally the Sewell House is representative of the form structure built for workingmen associated with the growth and maintenance of the Chesapeake and Delaware Canal.

This small house may have been built around 1854 since that is the date of the original lease to Henry Purnell, a laborer, from Richard H. Bayard. Working people have always lived here. At one time there was a wood shed and another building in the back yard. The house has an unrestricted view of the Canal.
