**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This house is a Victorian building two-and-a-half stories in height. It is frame with clapboard siding and has a stone foundation. The roof lines are different gambrel-hip and gable all being present. Additions probably caused this situation to occur. Most of the windows are 2/2 with a capped frame. Some stained glass is present. There are two interior brick chimneys with corbeled tops. On the south and west sides of the building is a one-story porch.

To the rear of the central portion of the house is a two-story wing that has a gable roof and a chimney in the northeast corner.
