DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Conrad House is a two-story brick house three bays long by two bays deep. The facade consists of a conglomeration of brickwork. Looks like combination of running bond and Flemish bond. Rest of walls American bond. Has one bay one story entrance porch supported by four square posts with dentil work at the top. An earlier porch ran the entire length of the facade. An "S" brace for support of the second floor is located under the porch roof. The front door has a 5 eight transom. The window frames are plain with 6/6 sash. The roof has a slate covering with two inside end chimenys. The gable ends have beaded barge boards and the roof has a box cornice.

The house has a stone foundation with full cellar. Floor joists sawn on two sides with bark on other two. Fireplace hearth supports are corbelled out from cellar wall. A frame addition has been built on the rear.
