The Owens House is a two story clapboard covered dwelling with an addition in the rear of the building. It is three bays long by two bays wide. There is a single inside end chimney in the south gable end. The window sash is six over six. The house rests on a stone foundation and has a porch on the facade and on the rear wall. The front porch has Victorian trim. The roof has asphalt shingles.
