DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This farmhouse is built of stone and is two stories in height. It is four bays by two and the exterior has been stuccoed. The roof has asphalt shingles with box cornice and crown molding. The facade had a one-story porch, but it has been removed. The walls are over 24" thick. There is a transom over the door.

At each end of the home there is an interior end chimney with a small window to either side. A two-story addition has been built to the rear of the early structure. The house has been completely remodeled on the inside.

Behind the house is a root cellar and the foundation of the garage looks to be of the same age of the house.
