DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This house is a two-story frame dwelling built on the side of a valley. The foundation is a full basement and the facade has a one-story entrance porch three bays long. This structure is three bays by two bays with a low pitch gable roof. The exterior woodwork has architrave trim and the window sash is six lights over six. The roof has a box cornice. The exterior of the building is covered with white shingles, but it was originally clapboard. There is an interior chimney in the east gable. On the interior there is a wooden mantle with dental molding and fluted columns.

To the west of this dwelling is the site of the Scarborough Mill. The only remains of the mill are two mill stones. The site has been disturbed by a bulldozer in recent years.
