DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The house is now a rectangularly shaped two-story frame dwelling with a two-story rear wing. The facade of the dwelling has a one-story two-bay 20th century porch. This house is four bays by two and has a stone foundation. The roof is of gable structure with a Victorian peak dormer in the center. The roof is covered with cedar shake shingles. There is also a box cornice.

Originally, the house was one-and-a-half stories in height with an interior chimney in the east end. A winding stairway was replaced by an open-string stair, in the early 1900's. The first addition was the room to the west which has an interior end chimney. The flooring came from lumber floated down the Susquehanna. Later a lean-to kitchen behind the east end gave way to a two-story wing that is there now. The sash was originally 6/6 but is now 2/2.

To the west of the house was a frame building used as a parsonage for the Leeds Church. Behind this structure was a large blacksmith shop. Both of these buildings were torn down in the 20th century.

STATEMENT OF SIGNIFICANCE

This home served several purposes during the mid- and late 1800's. The earliest known use was that the original section was a stagecoach stop. Later it became a post office. The adjacent building and property served as a parsonage and a blacksmith shop.

The building has no architectural merit and is typical of mid-19th century architecture.
