DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Thomas Brown Tenant House is a two-story frame building three bays long by two wide. Off the rear of the structure is a two-story wing two bays by two. There is an inside end chimney in the west gable and one in the north gable of the wing. The roof is covered with slate, and has a plain box cornice. On the facade is a one-story front porch with Victorian trim. The sash is 2/2 throughout. This house has a stone foundation with cellar under the front section.
