DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Kennedy House is a farmhouse built at two separate dates. The front section is distinctly Victorian while a rear wing is built of log. The front section is frame with a white shingle covering it is two stories in height with a gable roof. The rear wing is two stories in height and is two bays by two (front section is three by two); and has 6/6 sash. The entrance door into the rear section is board-and-batten inside and paneled on the exterior surface. There is a three/eight transom in the door. The east gable wall has an inside end chimney. Winding stairway.

Behind the house is a stone meathouse with a gable roof. There is a board-and-batten door with two different sizes of strap hinges. A barn barely stands of mortice and tenon construction.
