The Hovermill House is a two story frame dwelling that is three bays long by two deep (not full bays)/ In the rear of the house is a two story wing of similiar construction as the front section. The exterior walls are covered with stucco. The house has a gable roof with asphalt shingles. The foundation is built of fieldstone and there is a cellar beneath the house. The facade has a central bay enclosed porch protection it. On the east gable is a one story bay window with a shed roof. The window sash is 2/2.
