DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Little N. Y. Road Italianate House is a two story brick structure built in the Italianate style. It is three bays by three bays in size with a one story porch across the facade. The house has a hip roof with a box cornice supported by brackets which are attached to a frieze. The roof has a brick interior chimney protruding through its surface. The porch has brackets, and finials hanging from the porch roof cornice. The facade has a central entrance with sidelights and transom. The exterior surface of this home has been coated with stucco. The roof, also, has been altered for the original shingles have been removed and replaced by asphalt shingles. The window sash on the first floor is 2/2 and 6/6 on the second floor (there are two windows on the first story that have 6/6 sash). A small shed addition has been built on the rear of the house. There also is an entrance on the eastern wall of the house.
