**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

The Big Elk Chapel is a simple one story Greek Revival Church. It is three bays long by one bay wide. The building is of frame construction and covered with clapboard. It has a gable roof with return cornices. An interior stove chimney protrudes through the center of the roof. The windows have 6/6 sash and lowered shutters. The chapel has a stone foundation that has been whitewashed. In the center of the south gable wall is a door with a three light transom over it. Interior was not visible.

To the north of the chapel is a small stable of mortice and tenor construction.
