**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

St. John's Church is a large brick structure three bays long by four deep. The bricks are laid in common bond two stories in height. The roof is gable with slate shingles. The cornice has bracket supports and return cornices on gable ends. The windows on the first floor are 4/4 sash while those on the second are six over four. The second story windows have semi-circular tops. The center second story window has louvered shutters above it is a small marble date stone. The facade or est gable has a central entrance with a four light transom. The Church has a stone foundation and also a cellar. Between the first and second bay on the south wall is a narrow brick stove chimney.
