This three story, frame house, T-shaped, has asphalt shingle siding. Three bays by 3 windows it faces west with a wing 6 bays by 2 running east from the center of the house. The roof is almost flat, with two chimneys rising from flues on the interior walls. A front porch sheltering the front door is supported by Ionic columns of wood. (It appears that brackets at the cornice have been removed).
