DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Granite Post Frame House sits on a hill overlooking the small village of Childs. It is two bays by two and two stories in height. The house is frame with bevel siding, and has a stone foundation. The roof has an inside end chimney built of brick in the west gable end. The house has a gable roof and new shingles. On the rear of the house is a two story frame addition with a relatively flat roof. There is a single story porch on the front and rear of the building. The window sash is 6/6 and there are no shutters on the house.

There are several small outbuildings on the property in various states of decay. One has a brick chimney and could have served as a small shop of sorts.
