Stone Row#2 is a stone dwelling two ½ stories in height. It is three bays long by two deep. The stonework is covered with stucco in many places but is beginning to wear off. The gable roof has a tin covering with squat stone chimneys at each gable end. Across the facade is a one story front porch. The window sash is 6/6 except for the uppermost story which has 3/6 sash.
