DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This building is the southern most of a row of stone buildings dating from 1790-1810. This particular building is three stories in height and three bays long by two deep. It is built of stone with stucco and white wash applied to the exterior surface. Across the Facade is a one-story front porch which also appears to be of a later date than the house itself. In each gable wall is a large stone chimney with a cap around the top. It is very similar to the chimneys of the Red Ball Tavern which is near Fair Hill. The house has a gable roof covered with asbestos shingles. The roof has a plain box cornice with a barge board running from the cornice to the apex of the roof. Some early sash remains and is 6/6, the windows have no shutters.

The interior was not open at the time of the survey.
