DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Dr. Jack Road Log House is a one and a half story log structure built in the saddle notch style with med chinking. It is a very simple structure with one major room on the first floor. It is two bay by one with a smaller frame addition on the north gable end that may have served as a stable. In the north gable end is a large stone fireplace with a wooden lentil. The exterior of the building was first covered with studding and wooden siding, then in the 20th century the house was covered with asphalt shingles. The logs themselves appear to be from rafts that were made of logs and floated down the Susquehanna to Port Deposit. The house has a very low stone foundation and a part dirt part wood floor. The gable roof has pegged rafters and the remains of a wood shingle roof. There are no doors or door frames on the house nor are there any window sash. The window sash would have been 6/6.
