DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Weaver House is a frame building two stories in height and three bays long by two deep. The exterior of the house is covered with asphalt shingles. This house had two front entrances one of which has been boarded up. The gable roof has an inside end chimney in each gable wall. In the center of the roof is a peaked dormer with a pointed window. The south gable wall has a two story bay window. Across the facade is a one story porch with turned posts and scrole brackets. In the rear of this dwelling is a two story frame wing with a brick inside end chimney in the west gable. The window sash is 2/2 and the foundation is built of crudely laid stone.
