**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

The Smith House is a plain frame building two stories in height and three bays long by two deep. The house has a gable roof covered with asphalt shingles. There is an exterior concrete block chimney on the east gable wall. The facade has a central entrance and a one story porch. The porch has turned posts with brackets. There is a new brick chimney in the west gable. The exterior of this house is covered with aluminum siding.

Built off the rear of the front section is a two story frame wing, two bays long by one deep with an enclosed porch on the east side. The entire house has a stone foundation.
