**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

The William Bromwell House was most likely built in the early part of the 19th Century. Bromwell, a Quaker, moved into Cecil County approximately in 1825 and lived in this frame house. The house is five bays long by two deep and built in four distinct sections. The original house was two-bays square and two-storeys in height with a side bay entrance. There quite possibly was a summer kitchen off the rear of this section. In the west gable is a brick fireplace. The mantel on the first floor has a slightly stepped molding beneath the shelf. The Pilaster design is similar to those of the Twin Oaks Farm. The exterior surface was covered with clapboard. The cellar reveals that the flooring was made from lumber that had been rafted down the Susquehanna (due to the pegs). The stair hall has an open string stair with a turned post and straight, narrow balusters.

In 1827, Mr. Bromwell became ill and relatives moved down from Pennsylvania. A one bay-square two-storey apartment was built for them on the west gable of the earlier house. The box cornice carries over from one side to the other. The roof is entirely covered with asphalt shingles, but once had a wood shingle roof. About 1850, another addition was built on the east gable end approximately the same size as the original house. Sometime during the late 1800's a small building (frame which had been used as a school) was moved to the rear of this latest section. The sash is 6/6 throughout with mostly louvered shutters. The shutters have strap hinges and pitels indicating that they are from an earlier building. There are several board and batten doors and some six and four panel doors also. One door has a nice box lock. The facade has a two bay one storey entrance porch.
