DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Ragan House c. 1910 is a 2½ story frame duplex that was moved from Old Conowingo before the town was flooded. The house is located on the road from Oakwood to Old Conowingo. The house faces west with the main gable running north/south.

The main block consists of a 2½ story frame 4 bays across by 2 bays deep. A two story shed roof addition extends off the back of the house. A single story shed roof porch with granite plinths and square tapered columns, is found on the front of the house. The entire house rests on an uncoursed stone foundation and is capped with a steep slate roof with central dormer. The dormer has curved fishscale shingles and has two separate 6/6 sash windows. The eaves are extended and the rafters exposed.

The main facade is 4 bays across with two central bays as entrances. The outer bays are double 2/2 sash windows. The shutters are paneled on the first floor and louvered on the second. The window surrounds are plain with narrow extended caps. The 4 panel front doors have a single pane transom. The entire facade, as the rest of the house, is covered with a narrow weatherboard siding.

The south and north gable ends are similar in appearance with two 2/2 sash windows on each floor and two 1/1 attic windows that flank the exterior brick stove stack. The eaves are extended on the gable ends and the rafters left exposed.

The two story shed addition has a sloping tin roof. The southeast and northeast corners of the first floor were left open for a small porch area but inclosed on the second floor. A one story shed roof extends off the east side of this addition.

The interior was not open for inspection.


