DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Milestone No. 22(23) approximately marks Mason and Dixon's 22nd horizontal mile west of the initial stone at the northeast corner of Maryland, the beginning point of their West Line. It is a replacement of the original of 1766 with a new Port Deposit granite monument of a differing design in 1902, set at a better site on the Line further east, during the course of the 1900-03 Resurvey of the Maryland-Pennsylvania boundary.

The area here is predominantly rural, with a few scattered ^{open fields} farms, and residences, along the last ridge before the land slopes westward down to the Susquehanna River. The site is within Election District VIII of Cecil County, Fulton Township of Lancaster County; about 0.8 mile south-southwest of the scattered settlement of Pleasant Grove, Pennsylvania; about 1.15 miles due north of the small crossroads settlement of Pilot, Maryland; at the north end of Bell Manor Road (Pilottown Road) in the fork between PA T-456 and LR-36007; about 2' from the main road (LR-36007) in the road shoulder at grade level. It can be easily seen from the road, all seasons. According to the 1900-03 Resurvey, the original milestone here "was situated in the bottom of a hollow a little farther west and had been washed out and destroyed by the formation of a gully."

This new monument (and the one added to the Line on the west side of the Susquehanna River, now inundated) was described in the MGS Vol. VII (1908), pp. 74-75 as "of Port Deposit granite, 5'6" long, 12" square above ground, and with a flat top, though the surfaces to be buried below ground level were left rough "as it came from the quarry; weight about 1000 pounds." It remains in place, firmly set, in excellent condition; is a salt-and-pepper granite, dressed, and embellished only by very plain V-cut/^{blocky}capital letters, P on the north (Pennsylvania) side, M on the south (Maryland) side. Although unprotected by any posts, it has survived traffic and road maintenance machinery hazards, but is certainly endangered.

STATEMENT OF SIGNIFICANCE

There are 24 original crownstones and 111 milestones of 1766-67 still standing along Mason and Dixon's West Line, set at mile intervals through the 132nd mile, and including 12 added in 1902 beyond that point (3 crownstones, 9 milestones) set at irregular intervals. Milestone No. 22(23), though a new replacement in 1902 for one of the original milestones, and at a slightly relocated site, is primarily significant as one of the series/visually maintaining the integrity of the original West Line, and thus representing a boundary of national and state importance, which has symbolized the division between the north and south since Civil War days, and a century earlier was notable for the innovative survey methods used to settle the longstanding provincial boundary disputes. Individually and locally it is considerably less significant.
