DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This house is two stories high, three bays wide, and faces east. A one-bay screened porch shelters the central entrance, with 1/1 sash windows on either side and three 1/1 sash on the second story, aligned above the first-floor openings. A pair of interior chimneys rise from the ridge of the gable roof, defining the central bay. The building is clad in aluminum siding, with asphalt shingles covering the roof.
