**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This small west-facing house has three distinct sections. The northernmost of these is two stories high, two bays wide, and has a gable roof covered with corrugated metal. On the first floor, a doorway occupies the left bay, with a 6/6 sash window to its right. Two 6/6 windows appear on the second story; these are not precisely aligned over the first-floor openings. A brick interior end chimney rises from the south gable.

The center section is 1 1/2 stories high, shed roofed, and two bays wide. It has a doorway in its left bay and a 6/6 window on the right. A window appears at the half-story, above the door.

A one-story porch spans these two sections, featuring turned posts with stickwork brackets and a vertical-board balustrade; the location of the porch steps and the gate in the picket fence outside the small yard point to the batten door in the 1 1/2 story central section as the principal entrance.

Finally, a one-story, shed roofed, one-bay section extends to the south, featuring a single 6/6 window in its west wall and a brick chimney at the south end. The building is uniformly clad in aluminum siding.
