The Locust Point Farm was subdivided in the early half of the 20th century when the demand for waterfront property increased. Locust Point juts out into the Elk River and provided an excellent place to build summer cottages. The farmhouse has seen numerous changes as well with the addition of a third floor dormitory that could handle many weekend visitors at the shore. The present owners family purchased the property from the Boulden family in the mid 1880's (JAD 10/81) and have owned the property since.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Locust Point Farmhouse c. 1860 was originally a two story three bay by one room center hall frame structure whose roof was later raised to include a third floor. The house is located along the shore of the Elk River two miles south of Elkton. The house faces west and running on a north/south axis.

The main block rests on a fieldstone foundation as does the two story T wing to the east. The entire house is sheathed with asbestos shingle. The medium sloped roof is covered with composition tile.

The main facade has a central door which is flanked by a large picture window. The second floor is similarly arranged with a second floor door and 6/6 sash windows on each side. A small gabled hood protects the door. A definite seam shows the earlier cornice line. Instead the house continues to another full story with two gabled 6/6 sash dormers that are flush with the front wall. A single story front porch with balustrade and deck replaces a two story porch that appears in old photographs of the house before the raising.

The north and south ends have interior end chimney stacks with flanking sash windows.

The rear kitchen wing is three bays across by one room deep with a central entrance and corresponding 6/6 sash windows. The side porch covers the first floor of the kitchen. A recent single story addition was attached to the north side.

The interior has been remodeled to some extent with the removal of interior partition walls. The end wall mantels remain however with curved mantel shelves and machine cut and applied decoration.

The only outbuilding is a one story frame board and batten shop.

STATEMENT OF SIGNIFICANCE

By 1860 many people were finding the recreational pleasures of Cecil County waterways and not orienting their houses especially to the water just for easily reachable transportation. This house with its once expansive two story porch obviously wanted to take advantage of the water. It was built close to shore and ~~was~~ particularly oriented to the water. Wm. T. Boulden owned this farm in 1877 (Lake, Griffing, and Stevenson) but it does not appear on the earlier 1858 map.
