C. 1840-1860

Distinguished mainly by its brick construction with corbelled and dentiled cornices, this two story side hall/double parlor house type is as common to the countyside as it is to the Cecil County towns. The main two story three bay stretcher and common bond brick block has a shorter two story one bay by one room kitchen ell complete with corbelled cornices. The house is located along Blue Ball Road and designated on the 1877 Atlas as owned by a D. Mullen.
