Built in 1840 by Absalom and Jethro McCauley, this two story three bay single pile fieldstone house is typical of houses with Scotch-Irish owners at the time of construction. The once two room plan house has been extended by a frame ell addition. The first floor plan of the stone section has been altered with the partial removal of the middle wall. Boxed winder stairs still remain in the northwest corners of both floors.
