C. 1800-1820

This two story fieldstone house, which stands on land known historically as the Tyson Mill Property, is referred to in the house form chapter as a cross passage/two room plan. It is also pointed out that the form is one that was preferred and built by Scotch-Irish residents. Typical is its exposed fieldstone basement kitchen and bank location. Single story frame additions obscure a slightly later two bay by one room addition. The property is part of the extensive New Munster tract and owned in the first quarter of the 19th century by Matthias Tyson.
