DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Ewing-Cline House c. 1850 is a two story three bay by one room center stair weatherboard frame house off Fairview Road and northwest of Fair Hill. The farmhouse faces south with an east/west main gable orientation.

The front frame block has a two story two bay by one room "T" kitchen wing with shed additions. The entire house rests on a fieldstone foundation and is covered with a asphalt shingle roof with extended eaves and sloped soffits.

The south elevation is typically arranged with a central entrance and flanking 4/4 sash windows with three panel shutters. The four panel front door has arched top panels with a single light transom overhead. The first floor is covered by a hip roof front porch with chamfered posts that have simple capitals.

The east and west gable ends have two 4/4 sash on each floor and two 2/2 attic lights. Access to the basement is gained through the east end.

The kitchen wing is a shorter two story elevation. It is detailed the same as the main block. The east porch has been enclosed but the west side porch remains open. There are two openings on each floor and an exterior end chimney rises against the north wall.

The inside of the house was not seen but predictable. An enclosed central stair rises between two rooms. Mid to late 19th Century woodwork is found throughout.

Various mid 19th Century barns and farm related structures stands southeast of the house. The mid 19th Century barn has a large hay shed to the south. Dairies have also been added.
