
The Tosh-Basham Farm was erected around 1840-50 and contains elements of the Greek Revival and Victorian styles of architecture. The two-story brick house is a later example of a hall and parlor dwelling and contains sympathetic one-story additions to the rear façade. The main house block has retained most of its character-defining features, including a full-width, one-story porch with decorative scroll work along the front façade, six-over-six-light double-hung sash windows, three-light transom window over the front door, and wood louvered shutters. Historic photographs indicate that the original posts and railings were replaced. The current posts and railing most likely date from the late 19th century, reflect the Victorian style of architecture, and have gained historical significance. Several agricultural structures and outbuildings are situated on the property and represent its historic and current use as a farm. These structures include a barn, hen house, outhouse, and carriage house.

It is under criterion C that the Tosh-Basham Farm might be considered eligible for listing on the NRHP. The Tosh-Basham Farm embodies the distinctive characteristics typical of a late 19th century farm in rural, Northern Maryland. The house has retained its hall and parlor plan with a central staircase and front entry room as well as several outbuildings related to the property's historic use as a farm. The farmstead has a high level of integrity in setting, materials, workmanship, and feeling. The Tosh-Basham Farm is not associated with events, or persons important to local, state, or national history (Criteria A and B). It has not yielded, nor is likely to yield information important in prehistory or history (Criterion D).
