DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Quarters R is a two and one-half story frame building with a gambrel roof and stone foundation located on Anderson Road near Bainbridge Road on the former Bainbridge Naval Training Center near Port Deposit, Maryland.

The original section of the house is an L-shaped plan of two rectangular wings with gambrel roofs. The main section faces southeast and has dormers with paired windows on the attic level. At the west end of this section is a recessed open porch with granite piers supporting the upper stories. An exterior granite chimney is located at the wall of the house.

The other gambrel roofed section joins the main block at the southeast corner. This section also has dormers at the attic level. Further two-story additions have been attached to the rear of the original house.

The exterior covering is aluminum siding and the roof is composition. The main rooms of the first floor retain original mantelpieces in neoclassical style. The house was converted to apartments after 1942.

South of the house is a shingled barn (Building #38) with pegged construction.

STATEMENT OF SIGNIFICANCE

Quarters R is a good example of a late 19th century vernacular Colonial Revival house. Although greatly altered after 1942, particularly its interior, this house exhibits traditional design elements in its gambrel roof and neoclassical interior woodwork combined with contemporary details such as the open porch with granite piers.

The barn (Building #38) appears to be contemporary with the house and is interesting because of its pegged joinery, a technique more commonly used during the early and mid-19th century but surviving in rural areas until the first decades of the 20th century.


