Said to have been constructed of log and if so, would be highly unusual for the type, plan, and regional location of this house. Cousner's Manor was destroyed early in the 20th century.

One story in height with a gambrel roof the house had a centered door flanked by two windows (w later vict. sash) to each side. The exterior was sheathed with weather boarding. At each end stood two chimneys with free standing stacks. The roof had 4 shed roofed dormer windows.

At the west end was a frame hyphen and kitchen, the latter with an exterior end chimney.
