DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

This is a very small log cabin very probably built for the field hands of the nearby Spearman Lancaster farm.

The walls are of squared logs - there i deep cut dove-tailing and the chinking is composed of plaster, mud, hair, and straw, where there are large seperations between the logs saplings were used to help reinforce the bond. The front (W) and rear walls have 1 batten door and one crude window each. Each gable is unbroken except for the N gable which has a rather crude single flue chimney with stepped hips.*

The attic seems to have been enlarged by raising the roof and a single window cut into the top 1 1/2 logs on front and back.

Condition of this house is very poor. Th house has settled away from the chimney and although the exterior has been sheathed in asbestoes shingles it seems to have been done only when absolutely necessary for the logs and joints appear to be thoroughly rotten throughout.

*NOTE: Access to the interior was not obtained. There is a later 19th. century addition to the south gable with a door in this gable giving entrance. Difficult to date --- probably ca. 1800
