This balloon frame house began its history in the late 1800's as a small, two story, two bay dwelling with one room downstairs and another upstairs. According to Mrs. Harrison Dent, the present occupant and owner, she and her husband bought the property in 1907 and soon thereafter tripled the size of the house. This enlargement reflected the growing need felt by rural folk for private space and for rooms for specialized uses in the 20th century, in contrast to the earlier houses in which numerous and varied activities took place in shared spaces.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This two story, balloon frame house stands atop a knoll, facing south. It is surrounded by farm lands that are no longer cultivated. Remains of the working farm include the fields now in fallow and abandoned barn and farm equipment near the house. To the east side of the dwelling are several outbuildings, now used for storage and in need of maintenance. Directly in front of the house stands a massive oak tree, which the present occupant, Mrs. Janie Dent, remembers as a moderate sized tree when she and her husband purchased the house in 1907.

According to Mrs. Dent, who is 92 years old, the house originally consisted of a small, two story, two bay block with a small gable end kitchen. The gable roof was covered with wood shingles, and the frame by weatherboards painted white. The room downstairs was heated by a wood stove, a factor that suggests construction in the late 1800's (among black folk houses) as does the presence of wire nails in the framing members. Along the facade of the original block extended a shed porch.

In the 1920's a two story, two bay block of similar dimensions as the original section, replaced the small kitchen. The latter was removed and placed near the east end of the house, and served as a meathouse. A cross gable pediment without windows was also added. Later a two story two bay L was attached to the rear length, thereby completing the transformation of this originally simple dwelling into ~~that of~~ a substantial farmer.

STATEMENT OF SIGNIFICANCE

The changes made in this house by the landowning family in the 20th century illustrate the modern values toward household space and design that rural black families were able to express as they acquired the money to do so.

Since Mrs. Dent is rather infirm (though with a clear mind and ready wit), the grounds around the house do not reflect today the attention given to the place when it was a working farm. The interior, however, is colorful and well ordered and contains many of the family mementoes, reflecting her attachment to her family, and that of her children and grandchildren to her.

Mrs. Dent is the brother of Preston Janifer, whose house was also surveyed. The photograph of their father, an ex-slave, was copied as part of this survey and may be seen in the records of the Preston Janifer house, CH-


