DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

This is a small brick chapel of a character generally found in the Religion buildings of the Friends Society of Friends.

At the East elevation, facade, the building is three bays in length having a rather plain centered door flanked by windows with ~~2~~<sup>6</sup> panel shutters. The windows though shuttered probably possess over sash of <sup>6</sup>/<sub>6</sub> panes. The South ele. possesses two windows at the 1st + 2nd (gable) level with a small vent window directly above.

The A frame roof is presently sheathed in tin and the ridge runs N. to South. The walls are well laid in an English bond and all openings have jack arches. The panel arrangement of the shutters is a cross + Bible. At the base is a boxed cornice with a simple bed moulding.

The chapel is situate within an iron fenced enclosure directly on the west side of Grace Run Road approx. 1 1/2 mile south of the Md. / Penna. State line.


