DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

Though only briefly surveyed from the road this dwelling appears to be of great architectural interest. Judging from its exterior qualities the dwelling may very well contain better than average interior detail.

In the form of a large rectangular block the structure is two storeys in height and has a shallow hipped roof with a low cupola, also of rectangular dimensions, apparently multi-paned. A single chimney of great width stands $\frac{1}{4}$ the distance in from each end of the main block presenting a basis for conjecturing that each of the possibly four first level rooms possess cater-cornered fireplaces.

The wall fabric is stucco presumably over brick. The main block is, at the W. front elevation, five bays in length, viz., a large center door flanked by two windows at each side. The architecture is Georgian and probably dates about the third quarter of the 18th. century.

There is, to the S. end, a two storey wing of a possible later date.
