DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

The Sam's Creek Road House is a five bay brick dwelling situate on the North side of said road facing South. The house appears to be of mid nineteenth century construction possibly as early as 1825. Windows are 6/6 sash and the roof ridge runs East to West with two chimneys at the interior of each gable. Both pairs of chimneys are bridged just to a level slightly above the roof ridge.

The outstanding feature of the house is a small pedimented porch at the South elevation which has large round columns with Ionic caps. The porch is centered and is one storey in height.
