DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

Of brick construction and two storeys in height the Priestland Valley House is a typical rural dwelling of the CA. 1800 period in Carroll County.

At the S elevation (front) the dwelling is four bays in length; a single $\frac{6}{6}$ sash window at each end and two doors between. At the 2nd level are four windows. The roof plan is "A" frame running E-W with a single interior chimney at each extreme end.

Both W. and E. ends have two bays at each of the three levels — ground (1st. floor) to attic.

An $\frac{6}{6}$ center wing stands at the N. elevation (rear). Two storeys in height it also possesses an "A" frame roof the ridge of which runs N-S and is of brick construction.

A one storey very simply constructed farm porch with four squared posts ~~so~~ supporting a pent roof stands to the S. elevation, center.

May be late eighteenth century.
