

30 WEST GREEN STREET

As noted, the c. 1870 house is built in two sections, a not infrequent occurrence in Westminster. The main section is three stories tall, three bays wide and blind on its western side. The principal facade has the entrance door as the eastern ground story bay. It is approached by two flights of wooden steps which are simply railed. The door itself is a mid Victorian door consisting of two long vertical panels with a row of 6 lights in the upper third. The door is surrounded by side lights, by a rectangular transom, and is slightly recessed. The whole is surrounded by plain white boards capped by a full cornice, which is supported by pelleted scroll brackets. The other bays on this facade are identical double-hung sash windows with four-over-four panes. Windows have white wooden sills, three course gauged flat arches, and black louvered shutters. Fine corbelling eases the transition between wall and roof on this and on all other facades of the principal section.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Number 30 West Green Street, Westminster faces the north side of that street a few feet east of Belle Grove Square. The two-sectioned house sits on low, coarsed, fieldstone foundations, and is clearly meant to be one of a pair, the other member being its immediate neighbor, 34 West Green Street.

As noted, the house is built in two sections, a not infrequent occurrence in Westminster. The main section is three stories tall, three bays wide and blind on its western side. The principal facade has the entrance door as the eastern ground story bay. It is approached by two flights of wooden steps which are simply railed. The door itself is a mid Victorian door consisting of two long vertical panels with a row of 6 lights in the upper third. The door is surrounded by side lights, by a rectangular transom, and is slightly recessed. The whole is surrounded by plain white boards capped by a full cornice, which is supported by pelleted scroll brackets. The other bays on this facade are identical double-hung sash windows with four-over-four panes. Windows have white wooden sills, three course gauged flat arches, and black louvered shutters. Fine corbelling eases the transition between wall and roof on this and on all other facades of the principal section.

As noted, the east and west facades are blind, except for, on each side, a small four-light attic window located within the gable. The western facade shows the development of the house: the original other section is two stories tall under a gable roof and has here four (two per floor) regularly spaced 4/4 windows which are identical to those on the principal facade, as is the eave's corbelling. This section probably originally had a two-tier porch running along the length of its eastern facade; this has been covered now on the second floor by clapboarding which is pierced by two pairs of narrow 4/4 windows. The remaining ground story porch is approached by single flight of wooden steps and leads into the house by means of a many-panelled door.

The north gable end of this section is marked by a small brick corbel-capped chimney rising at the roof's peak flush with the original north wall. Since the house was built, other extensions have been created: a two-bay two-story box to the north (the 4/4 window on that western facade is shutterless) and an asbestos shingled extension of similar dimensions off of it. The asbestos shingle section has a small 6/6 window on its second story of the west facade, and regularly aligned 4/4 windows one per floor to the north. A rounded capped brick chimney rests between these two sections to the west, a few feet down from the roof's peak.

STATEMENT OF SIGNIFICANCE

Number 30 West Green Street, probably built by Jacob Morelock in the 1870's, is architecturally interesting as yet another example of the vernacular style that dominated the building in this area a 100 years before this houses construction. Moreover, 30 West Green Street is interesting as a near final example of the style: even as this house is being built, other more innovative, more alien, styles were being brought into Westminster and would soon lead buildings in the City to follow more national trends. Nevertheless the large house is a fine culmination, in its detail as well as in its overall proportion, of the style.

Jacob Morelock bought this lot number 2 from George W. Matthews on June 20, 1870, for \$600 (Carroll County Deed Book 38, Page 439); his creditors, William Mckellip and Hashabiah Haines sold the same lot five years later to Joshua Sellman on April 28, 1875, (45/136).

The price they were able to bring for the lot was \$4000, which would certainly indicate the presence of a new house. Sellman kept title until March 24, 1898 when the place was sold for \$2200 to Roberta Shriver and others (86/384). These various Shriviers held the house until July 25, 1916, when their trustee, Thomas G. Shriver, sold to George E. Marker (127/407). Marker's heir, Elizabeth, sold to Oden C. Corbin on October 4, 1939 (171/314) who sold to the present owner on January 24, 1947.
