1130 Martin Drive is shown as the Adam Miles residence on the 1877 map. It is a log structure built into a slope so that it has a full-level at the basement on the east gable end. The house is situated at a prominent location along a slight hill. Its asymmetrical facade, L-shaped plan and other details are representative of the log construction tradition on this region.
