274 Sullivan Road is a brick farmhouse of the mid-nineteenth century. It is situated into a slope and has a wrap-around porch on the main facade and north gable end where the full-basement level exists. While the house has some of the regional farmhouse characteristics, its asymmetrical facade links it to the early Germanic tradition of building in this region.


