The Stone House Farm is a house and farm complex that is representative of Carroll County's mid-19th century agricultural heritage. The house was constructed in two sections with the four-bay stone section depicting the regional farmhouse style. It has a entrance in the second bay from the north and windows on the symmetrical main facade are nine-over-six pane sash windows with plain wood lintels. On the south gable end is a two-story frame addition that dates from the early twentieth century. The property also contains a frame tenant house, late nineteenth century bank barn, and other farm buildings.

SUMMARY: The Stone House Farm represents a farmhouse and farm complex from the mid-19th century. The four bay stone section of the house with an L-shaped plan was constructed in 1846. It has a single entrance with nine-over-six pane sash windows with plain wood lintels. On the south gable end is a two story frame addition that dates from the early 20th century. The property also contains a frame tenant house, late 19th century bank barn, and other farm outbuildings.

DESCRIPTION: The Stone House Farm is located on the west side of Maryland Route 27, approximately one-half mile south of the City of Westminster. The farm is set back from the road at a site with a stream running in front of the house. The main facade of the structure faces east.

The architecture of the Stone House Farm depicts the regional farmhouse style in stone construction. The original house was four bays by two bays, two stories in height, with a gable roof, symmetrical facade and L-shaped plan. The house was built by Solomon Myerly about 1846.

A newspaper article in the June 12, 1886 edition of the Democratic Advocate describes this farm property which was then owned by Jacob Myerly. The description of the house states:

"The house is built of the best honey-comb stone, and was erected by his father, Mr. Solomon Myerly, about 1846, the stone being taken from a quarry on the farm. It is 34 feet front by 20 feet, two stories high. The back building is two stories also, 31 feet in length by 17 feet in width, the whole containing eight rooms and a hall. The front building is adorned with a handsome porch, and the back building with a porch and pantry. The whole building is a piece of superb masonry still in an excellent state of preservation. The interior of the building is also well finished. The parlor and the dining room walls and ceilings are painted in oil and laid off in panelwork presenting an ornate appearance.

The article also describes the lawn which contains shade trees and flowers with a lattice summer-house and other out buildings. The buildings on the property included a bank barn built in 1846, a corncrib-carriage house, wheelwright shop, blacksmith shop, piggery, wagon shed, hen house, smoke house, wood house and bake oven. The property also contained an up to date stone dairy 15 feet square with a large cement trough. The

floor of the trough was composed of two large smooth flagstones from the Alms house quarry. The dairy was supplied with spring water through iron pipe from a nearby spring.

SUMMARY: The Stone House Farm depicts the architecture of a prosperous mid-19th century Carroll County farm. The farmhouse uses the regional farmhouse style but its stone construction is a symbol of the farm's affluence. Also, the barn and existing outbuildings are representative of this period of Carroll County's agricultural heritage.

HISTORY: The Democratic Advocate of June 12, 1886 provides a short description of the history of this property at that time. The farm was begun by Solomon Myerly who built the stone house about 1846. In 1867, 80 acres including the house was purchased by his son, Jacob Myerly. Jacob's holdings also included other land purchased to total 115 1/4 acres. The other lands included a Victorian frame dwelling house (Calico House, CARR-799) and a log house and farm complex (Myerly Log House; CARR-809). The article describes the buildings and agricultural enterprises on the property.


