DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

1856 Building ... (from photo) was a two-bay front, three-bay side coursed to uncoursed stone structure with large stoin quoins. Windows were 6/6 with louvered shutters, wooden base and lintel. The front door had a Tudor arch with plain trim. The gable roof supported a front square, shingled belfry, with pointed arch openings on all sides. These had decorative railings, decorative brackets under the cornice and a spire. Its right, back side supported an interior, single brick chimney.

The cemetary stood behind.

1907 Present Building ... is located right off the west side of Emory Church Road, and level with it, (Md. Rt. 91) facing east.

It is not 25 yards from the Baltimore County line.

The short, L-shaped, plan building, with corner tower, has walls of brick, either running or Garden wall bond, and an uncoursed stone foundation with large stone quoins. The two gable roofs and tower spire are capped with asphalt shingle. They end in eaves on the side, and soffits on the gable ends.

Eastern Front ... consists of the gable end of the long arm and the entrance tower. The onebay of the gable end had a large multi-paned stained glass, triangular arch window, with protruding brick voussoir work. A stone above the window reads "Emory M. E. Church, 1856-1907". Dripping corbelling under the cornice of all the gable ends and elsewhere on the structure unifies the architectural scheme. This eastern gable end accomodates an inside end, single brick chimney. The wall, like the entrance tower is of running bond.

The square front tower was a 6/panelled, double wooden door, approached by contemporary cement walks and steps. A three-part, pointed arch, stained glass transom is trimmed with portruding brick voussoir. Above the door and in the middle of the tower is corbelled brickwork. The same is true on the southern tower wall which houses a triangular arch, stained glass window with the same trim as others. The square wooden open belfry has railings, decorative panels, and minimal bargeboards, on each of four sides. The heavy cornice has a single row of dentals. It is topped with a four sided spire roof.

The North & South Side Walls ... each have a three-bay, gable end, made up of one large central window and one smaller window flanking either side. Trim is the same as aforementioned windows. The northern side has two additional bays of windows on the north walls of the large arm, of the same trim. This side also has two bays, of three pane windows, with rounded arch brick voussoir on the gable end wall, and inserted in the stone foundation (basement).

Both north and south side gable ends have a round window under the point, trimmed with brick voussoir. The north side has stained glass in it, the south does not. Both walls have a Garden Wall bonding pattern as does the western back wall, which is four bays across, with basement windows, the same as the north wall. Trim on these windows is the same as others, but the voussoir work does not protrude. A large central 3-sided offset in the back wall and roof, accomodates two of these windows which are smaller in dimensions than the farthrest side ones. The back wall is Garden wall bond.

STATEMENT OF SIGNIFICANCE

In 1836, John Williams gave the ground on which later was built a log house, known by the name of the United Seminary, a place for education and worship. About ten families are said to have worshipped there at the time.

In 1856, a stone building, described in #7, was erected on the ground, to be used as a place of worship, and was called the Brown's Meeting House Branch. The name was later changed to Emory Church in honor of one Emory Chenoweth, one of the more active members at that time. The stone church was completed in 1856, and the Log Meeting House was used for a school. Later the latter was covered with weather boarding, and used until the brick school was built, in 1885. The brick building still stands south of the church. It was used as a school until 1927, when it gave way to the consolidated school in Hampstead.

In 1928, the Ladies Aid Society of Emory Church purchased the old brick school to be used for a Social Hall for the church.

In 1907, the stone church was razed, and the present structure put up. At the conference of 1910, Emory, Pleasant Grove and Wesley Churches were detached from the Hampstead Circuit, forming a separate circuit and became known as Emory Circuit. Boring was later added to make Emory a four part circuit.

Emory, like so many small churches that dot the county, does not have an earth-shattering history. What is so nice about this structure, thus significant, is its pleasing light, neat and unified architectural features that make the small brick church a fine point in the county.
