Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

The Refrigeration Shop lies east of the Central Storeroom and southwest of the Powerhouse. The one story building displays a combination of construction materials: half of the building exhibits cement blocks with rough faces; the remaining half is constructed of stucco. The stucco portion of the building dates to 1923 while the cement block dates to 1939. The building forms a T shaped layout with the projection off the south wall measuring three bays by three bays. The north wall measures nine bays long. The entire building is covered by a flat roof.

The T projection lacks any windows on the cement block facade. The south wall of the projection does show a meat locker door and air vents. The eastern portion of the building displays the cement blocks interrupted by a molded string course. A bracketed cornice lines the east and a portion of the north wall. The few windows display an 8/8 sash and no lintels.

The older section of the building occupies the northwestern portion of the building. The walls exhibit a stucco finish over cast concrete. The building rests on a concrete foundation. The window openings appear on the north wall but the openings were sealed with cement. The lintels and sills have been painted. A string course runs above the windows. The stucco cornice bulges outward before a parapet rises from the flat roof.

The Refrigeration Shop has served several functions. The functions have all related to the slaughter and storage of beef products. The building provided a valuable service for the farm operation of the hospital. Springfield maintained an array of animals suitable for slaughter and this building provided the means to begin the process of converting the animal into an edible product.

The architecture of the building is a mixture of elements and is basically unadorned. The industrial and farm buildings received less ornamentation and displayed more of a mere functional appearance. The building moderately contributes the architectural integrity of Springfield State Hospital.
