At the 7 July 1902 meeting of the Carroll County Board of School Commissioners it was noted in the minute book:

Whenever the community has finished a school house according to the regulation specifications for Public School houses in Carroll County...the School Commissioners will pay the sum of seven hundred dollars (\$700.00) to the builders of said house

The Annual Report for Fiscal Year 1903 states that the school was 32 feet long by 26 feet wide and eleven feet high. The building cost \$720 and furnishings another \$98.07. It is not known what year the school opened, but the lot was transferred to the Board on 20 September 1905. The Board sold it at the end of 1926 for \$205. When and why the school closed is also unknown.

The former school building at 2506 Mt. Ventus Road is one story, 6 to 1 common-bond brick building on a rubble fieldstone foundation. It is a three bays wide and three bays deep, with segmentally-arched windows containing wood 4 over 4 double-hung sash. The building is oriented with the gable end as the front, facing the intersection of Mt. Ventus #1 and Mt. Ventus #2 Roads. This facade has the centrally-located entrance with large single light wood and transom. There is a gable roof covered by standing-seam metal.

The former school building at 2506 Mt. Ventus Road is a one story, 6 to 1 common-bond brick building on a rubble fieldstone foundation. It is three bays wide and three bays deep, with segmentally-arched windows containing wood 4 over 4 double-hung sash. The building is oriented with the gable end as the front, and faces the intersection of Mt. Ventus #1 Road and Mt. Ventus #2. This facade has the centrally located entrance with large single light wood door and transom. The sides of the doorway have alternately mouse-toothed and conventionally-laid bricks that create a decorative framework. This mouse-toothed brick is repeated in three rows above, in the gable end. Above this decorative band is a single, centrally-placed 1 over 1 double-hung sash. In the central bay of the front facade has been added a half-hip porch roof supported by tapered square wood posts on a concrete block foundation. There is a stone panel in the gable end that is inscribed "Mt. Ventus Sch. #13 Dist. #6." The school has a gable roof covered with standing seam metal and a flush brick chimney centered on the rear gable end. Also, on the rear elevation is a one-bay, one-story wood frame addition with a shed roof and asbestos shingle siding.

The interior was not accessible, but has been cut up from its original one-room plan to three or more rooms. It apparently does retain its vertical tongue and grooved Wainscoting, at least in places.

At the 7 July 1902 meeting of the Carroll County Board of School Commissioners it was noted in the minute book:

A delegation appeared before the Board in behalf of a new school house in Manchester District about two miles from Wentz's. It was ordered that whenever the community has finished a school house according to the regulation specifications for Public School houses in Carroll County, on a lot for which the school board has a legally recorded deed, then the School Commissioners will pay the sum of seven hundred dollars (\$700.00) to the builders of said house. (President Blocher was appointed a committee to locate the lot for said house, the lot to be donated to the school board.)

Significance (continued)

Perusal of the minute books over a several year period reveals that there were many instances where the school board solicited bids and hired a builder to construct a school house. Presumably, this was done where there was the greatest demonstrated need, although politics may have played an important role, too. The school board budget always seemed inadequate for the implied needs, so apparently the school board had provisions for communities with lower priorities that wanted a school. As long as the region provided the lot and built the structure according to the Board's specifications (which have not been uncovered) the Board would reimburse at least a large part of the cost of construction and would operate the school. On 3 November 1902, the Board carried a motion to order a bookcase and chair for Mt. Ventus School. The Annual Report for Fiscal Year 1903 states that the school was 32 feet long by 26 feet wide and eleven feet high. It had outbuildings (presumably two outhouses, one each for boys and girls) but was not fenced. The building cost \$720 and furnishings another \$98.07, and was equipped with 48 square feet of blackboard.

It is not known what year the school opened, but the lot was transferred to the Board on 20 September 1905. The Board sold it at the end of 1926 for \$205. When and why the school closed is also unknown.




