Three stories in height, the North building is covered with a shallow hipped roof pierced by tall brick chimneys and supported by bold brackets. A "widows walk" has been removed from the roof and a store front added. A mid nineteenth century building with Italianate verticality and detailing, it is one of the few of its type in Easton to have survived without substantial alterations.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This three-story frame building stands on the east side of Washington Street. At its north side is another three-story structure, the brick Masonic Hall; to the south is a modern two-story office building. The building faces west.

The structure is three bays wide and two bays deep. The three stories are each quite tall giving the building a strong vertical quality. The low hipped roof was once topped by a wooden cresting, a remnant of which remains. To the rear of the building is a two-story ell; it is three bays long and wide. It may be contemporary with the main house; a kitchen fireplace remains in the back room.

The window openings are evenly spaced on each facade. The window sashes used are four over four. Louvered shutters flank the windows on the upper floors. The very wide frames are trimmed with heavy moldings.

The main entrance to the building is in the northern bay. There is an overlight in the segmental arch opening above the door; it has three lights. Sidelights flanking the transom and the door have deeply molded panels beneath. The transom bar has a row of tiny brackets. The door itself has four panels decoratively treated with heavy moldings.

A modern store front, added to the two southern bays, is not unsympathetic to the building design. The bracketed cornice, possibly dating from the nineteenth century, has been incorporated into the design. The central entrance leads to a suite of law offices occupied by the owner of the building. There are two large windows to either side of the door. The cornice at the roof shows the influence of the Italianate style on building design in the second quarter of the nineteenth century. Closely spaced scroll-type brackets carry the widely projecting cornice, enlivening this simple, geometric structure.

The building retains most of its interior details. The stair is quite elaborate with heavy newel topped with an octagonal lantern: turned balusters and foliated step brackets are used on the open-string course. Although this is a standard catalogue stair readily available in the mid-nineteenth century, it is well-proportioned and rather grand.

The builder of this structure maintained the bold, even massive scale throughout the building. On the interior, the ceilings are very high; door and window surrounds are wide, about seven inches, and decorated with broad, deep composite moldings. The rooms are spacious and airy.

Two chimneys rise at the side walls; they are tall and have corbeled caps.

The building is used as apartments on the upper floors. The structure retains its early character and is well maintained. It is covered in aluminum siding painted beige. Trim is brown.

SPECIFIC DATES 1845-70 BUILDER/ARCHITECT CHARLES H. STEWART

STATEMENT OF SIGNIFICANCE

This building is significant for its architecture. It is representative of the buildings constructed after the decline of the Federal style, and shows Italianate verticality and detailing. Probably built during the middle of the nineteenth century, the building is one of the few of its type in Easton to survive without substantial alterations.

L433/F578 The North Building, as it is now known, was conveyed to John C. North II from John C. and Mary L. North in 1969. It has 40 feet frontage on Washington Street and adjoins the Masonic Building which stands on the North boundary. The property has been owned by the North family since 1920 when Robert North and William Neal bought the land and premises from Grace Howell and her husband and Mr. North bought out Neal's interest the same year. The building had earlier been purchased by E. L. F. Hardcastle in 1895 when he paid \$2000.00 for it at a sale of Richard H. T. Council's holdings to satisfy his creditors. Charles H. Stewart bought this and the adjoining premises to the north in 1866 from the estate of Miss Ann Smith and was living here when the northern two lots were sold to the Coates Lodge of Masons. Earlier deeds for those three lots describe only small shops and dwellings on them. It seems probable that Mr. Stewart built this as his home.




