From available information assembled in the chain-of-title along with the architectural evidence, it appears this two-story, side hall-parlor frame house was erected by James Jefferson around 1850, shortly after he began leasing the lot from Samuel A. Harrison in 1849. In December of 1850, James Jefferson mortgaged the property to James M. Seth, and the document includes the phrase, "...where Jefferson resides." Seven years later, Seth sold the house to John T. Ford for \$340. Beginning in 1915 the property was held by the Marshall family who finally sold the property in 1980.

The James Jefferson house, now St. Michaels Realty office, survives as one of the oldest frame structures standing along Talbot Street within the central business district. Although the exterior has been reworked with, the interior remains with a period entrance and stair.

Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

The James Jefferson house, now the location of St. Michaels Realty office, stands on the east side of Talbot Street in the center business district of St. Michaels, Talbot County, Maryland. The two-story, two-bay frame structure faces west with the principal gable oriented on a north/south axis.

Built around 1850, this two-story, side hall/parlor house is supported by a minimal brick foundation and sheathed with a layer of vinyl siding. The medium pitched roof is covered with asphalt shingles. Covering the front of the main block is a two-story porch that has been enclosed to provide additional office space.

The west (main) elevation is a modern three-bay storefront with a side entrance and a pair of adjacent display windows. Located above the first floor openings and stretching across the full front is a shingled eave. The second floor is lighted by a pair of six-over-six sash windows.

The south gable end is marked by single six-over-six sash windows that light each floor of the former porch, and a stuccoed brick stove stack protrudes through the gable end. The eaves are slightly extended. The north gable end, on the other hand, is largely obscured by the shop which stands directly north. Extending from the east (rear) elevation of the main block is a twentieth-century service wing.

The interior of the house has been generally modified as an office, but several mid nineteenth-century features remain intact. The front door of the house, located in the northernmost bay, is partially glazed and it is framed by three-light sidelights and a three-light transom. Fixed in the northeast corner of the side hall is a tight winder stair that survives with a slender, turned newel post and a circular profile handrail. Two square balusters to each tread support the handrail. A beaded board-and-batten door opens into the closet space beneath the stair. The balance of the first floor has been generally reworked with the removal of most mid nineteenth-century finishes.

SIGNIFICANCE

The James Jefferson house survives as one of the oldest frame structures standing along Talbot Street within the central business district of St. Michaels. Built during the middle years of the nineteenth century, the interior retains a period entrance and a winder stair. The two-story front porch, a common feature for mid nineteenth-century houses in St. Michaels, has been enclosed. Despite the exterior alterations, the two-story side hall-parlor house contributes to the row of nineteenth-century structures that line Talbot Street.

HISTORY AND SUPPORT

From available information assembled in the chain-of-title along with architectural evidence, it appears this two-story, side hall/parlor frame house was erected by James Jefferson around 1850 shortly after he began leasing the lot from Samuel A. Harrison in 1849. In December of 1850, James Jefferson mortgaged the property to James M. Seth, and the document includes the phrase, "...where Jefferson resides."(63/85) Seven years later, Seth is recorded selling the house to John T. Ford for \$340.(67/517) Beginning in 1915 the property was held by the Marshall family who finally sold the house in 1980. (550/467)

The beginning stone #16 definitely locates the beginning as the IOOF corner of Talbot and Carpenters Alley. Stones 15 and 16 were mentioned in the Survey of 1806 as the corner stones of Carpenters Alley and Talbot Street. This deed takes in all the land on Talbot Street from the corner of Carpenters Alley south to the lot of T-573 (Keeler Gallery) and includes the IOOF Hall.



NOTES A lot at the S corner of Carpenters Alley and Talbot Street. Begins at the NW corner of lot number 25 on Carpenter Street; run S 89'; then SW 11' to Talbot Street; then N 87' to Carpenters Alley; with the alley 21' to the beginning.
17 July 1849.

This is the earliest deed in which this property is identifiable. It appears to be a lot 11' to 21' deep with a frontage of 87' on Talbot Street. It includes part of the Odd Fellows lot, T-586 and T-587. It is definitely Harrison land - part of "Joseph's Lot" or "Stopper". It's early history is involved in the missing title of Samuel H Wrightson. From a study of the above deeds it would appear that Wrightson sold the FEE title while Samuel A Harrison sold the leasehold interest.


